The Ohio Future Problem Solving Program and its Advisory Board hereby agree to the assignment of the above named party as an Ohio FPS evaluator and/or tabulator. This assignment shall begin November 1, 2008 and conclude April 25, 2009. This assignment could possibly include up to six evaluation days. The above named employee agrees to accept such assignments for a stipend of \$60 for each team evaluation of a minimum of 5 booklets. (Samplings of less amounts will be paid at a \$50 stipend) Tabulators shall receive a flat \$60 per day. Evaluators who live more than one hundred (100) miles from the evaluation site will receive fifty (50) dollars to offset housing expenses (Receipt Required). **Stipends will be paid at the completion of the day of evaluation.** Stipends will be payable only for those days on which the evaluator/tabulator works on behalf of the OFPS program. Said employee agrees to accept such assignment at the stated stipend under the following conditions:

- Evaluator/Tabulator agrees to abide by the rules and regulations of the Ohio FPS Program. (Ohio's By-laws are available on request.)
- Evaluator/Tabulator agrees to accept such assignment or reassignment of levels and/or days as will best serve the welfare and efficiency of the program. This will be determined by the Evaluation Director.
- Ohio FPS Program reserves the right to terminate this contract at any time for good and sufficient cause.
- All compensation will cease at the date of termination and/or reassignment.
